## COVID-19 Precautions:

Keystone Canine Training Club is committed to offering a safe environment for our members, competitors and dogs. Please abide by the following precautions while attending our trial:

- Stay home if you have any symptoms of illness (fever, cough, etc) .
- Maintain social distancing from other people and dogs (6 feet separation) in the parking lot, potty areas and in the building.
- Everyone must wear a face mask in the building and are encouraged to do so when socializing with others in the parking lot. You may remove your mask once you have entered the starting square or at the start line with your dog. After finishing, please put it back on.
- Bring your own water and food. - When using the restroom, wipe off faucets, handles, light switches and door knobs with sanitary wipes (or use disinfectant spray) before you leave.
- No observers or visitors will be allowed in the building.
- Briefing will be outside at 10:45am.
- There will not be a walk through.
- Crating will be outside in your car.
